Re: Respecting CUPE & OSSTF Workplace Sanctions

Custodians in our school board are with The Canadian Union of Public Employees (CUPE) and Educational Assistants (EA) and Office Administrators are with the Ontario Secondary School Teachers Federation (OSSTF) and these organizations have entered into work-to-rule sanctions. As unionized workers we need to respect their work sanctions and not take on work that would belong to these groups.

CUPE has entered into Phase 2 of their work-to-rule. OSSTF has entered into a limited withdrawal of services.

No OECTA member is to perform any duties that were previously performed by or assigned to a CUPE and/or OSSTF employee, even if directed by school/board administration. If such direction is given, you should contact the Unit office as soon as possible.

No OECTA member is to direct, ask, or request a student to perform any duties that were previously performed by a CUPE and/or OSSTF employee, even if directed by school/board administration. However, you are not to interfere if a school board administrator directs a student to do such tasks. If this occurs please advise the Unit office as soon as possible.

We have always worked as a co-operative school community, one that helps each other. At this time I would ask that OECTA members refrain from:

CUPE

picking up garbage (halls, cafeteria, classroom) washing blackboards, whiteboards, or empty pencil sharpeners sweeping asking for supplies to be delivered to classroom any custodial duties

OSSTF

re-assigning EA's if anyone is absent request photocopying to be done assigning supervision

Please report all concerns to your administrator and/or Health and Safety Rep.


