The President's report was attached to the Agenda. The President provided a brief review of the report.

The Treasurer's report which was attached to the Agenda included a year-to-date budget.

The Human Rights Committee report was attached to the Agenda. The Chair provided a brief review of the report.

The Professional Development Committee report was attached to the Agenda. The President provided a review on behalf of the Chair.

NEW BUSINESS:

The Speaker congratulated Allyn Janicki on being elected/acclaimed to the position of President. He then detailed the process for the election of Executive officers and the three opportunities for members to declare their nomination from the floor.

Beginning with the position of First Vice-President, one nomination was received from Terry Beaumont, further nominations from the floor did not result in additional candidates. The position of First Vice-President was acclaimed.

There were no nominations received for the position of Recording Secretary. Nominations were opened from the floor. Greg Quinn and Steven Zawacki indicated they would like to run for the position. The candidates were provided an opportunity to speak to those in attendance. Ballots were handed out and collected once members in attendance made their selection. The Elections Chair counted the ballots and indicated that Steven Zawacki was elected to the position of Recording Secretary.

There was one nomination received from Anne O'Neill Bradt for the position of Councillor with a maximum of five for the position. The Elections Chair asked for further nominations from the floor. Jason Janisse and Greg Quinn indicated they would also run for the position of Councillor. Seeing no further nominations and the ability to have five Councillors, the three candidates were acclaimed.

That **Teacher Bargaining Unit By-Laws, Article II, Bargaining Unit Organization, Section 1 - Bargaining Unit Executive, 2.** (page 16) be amended by deletion of "**2.74**" and insertion of "**2.134-2.134.5**". It would then read:

2. The duties of the teacher bargaining unit executive shall be as defined in the Association Handbook By-laws **2.134-2.134.5**.

That the Provincial **Human Rights Statement** be appended to the Unit By-Laws immediately following the OECTA Prayer and Pledge on the inside of the front cover. (Copy attached).

That the Provincial Handbook Policies 3.158 to 3.205 - Safe Workplace and Member Conduct Policy - be added as an appendix to the Unit By-Laws. (**Copy attached as Appendix I**).

That the Provincial Handbook Policies 3.206 to 3.240 - Sexual Harassment Policy - be added as an appendix to the Unit By-Laws. (Copy attached as Appendix II).

No changes were suggested as the only revision was due to the need to correct a reference to the Provincial Handbook and attaching of Provincial policies. The following motion was presented to approved the revisions:
