## **School Based Meetings**

We have language in our Collective Agreement that outlines guidelines around Staff Meetings. Staff Meetings are to take place once a month, for up to one hour in duration. The Association encourages all members to attend these meetings, however, if you are unable to attend, please inform your principal in a timely manner. A schedule for all the monthly staff meetings for the 2021 - 2022 school year should be established this month, if not already.

All other meetings before or after school are strictly voluntary and no one should be disadvantaged for not attending a voluntary meeting. These meetings are not to be in place of monthly Staff Meetings. These voluntary meetings include division meetings; school improvement meetings; weekly morning meetings; lunch meetings and any other type of scheduled meeting that takes place outside of the instructional day.

### YOU MUST COMPLETE THE SAFE SCHOOLS INCIDENT REPORT (Link)

Violent Incident and Safe Schools Reports - be sure to check the box requesting a "debrief" of the event. This ensures that the principal can write a narrative about what was done to address and correct the situation. If you don't do this, they just choose generic items from a drop-down menu.

The lack of a Debrief and follow up was a deficiency noted by the Ministry of Labour.

2. If you have an injury from a violent incident, you should fill out an accident/incident report as well. This is prompted on the SSIR/VI. This is important for any possible WSIB claims.

### **Annual Learning Plan (ALP)**

The Annual Learning Plan is the responsibility of the teacher to complete each year in between their Teacher Performance Appraisal (TPA). Teachers are advised to keep copies of their yearly ALP and submit them each year to their principal.

According to the Central Terms it states: The Annual Learning Plan (ALP) is a component of the performance appraisal framework for experienced teachers. Experienced teachers must complete/update their ALP in accordance with Ministry and regulatory requirements. The ALP is teacher-authored and directed and is developed in a consultative and collaborative manner with the principal or designate.

Unfortunately, the site we used in the past (teachersalp.com) has shut down and we have not found a replacement.

# **OECTA Dues and College of Teachers Fee**

With the beginning of the new school year, OECTA Dues (local and provincial), and the College of Teachers Fee for the 2021-22 school year will be deducted from your pay. OCT fees are based on the current fee - \$170 - and will be spread over 9 payments from September to December. Teachers on leave (Maternity, deferred leave, unpaid etc.) are responsible for payment of their own fee.
